

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.autonomiq.io and AutonomIQ, Inc and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to AutonomIQ, Inc include www.autonomiq.io and AutonomIQ. The AutonomIQ website is a Informational site. By using the AutonomIQ website, you consent to the data practices described in this statement.

Collection of your Personal Information

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through AutonomIQ's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site.
